- Exemption from random selection of test samples, subsequent batch testing after the expiry validity of test reports, updating of CMVR, COP & Type approval applicable to Tractors, Power Tillers, Combine Harvesters and other self propelled agricultural machinery is allowed till 31.12.2020.
